Terms and Conditions

1. **Ownership.** By enrolling the above named and described dog, I represent that I am the legal owner of the named dog. Initial _____
2. **Payment.** I agree to pay the applicable rate of services prior to my dog's participation in any Mind Your Manners Dog Center LLC's ("MYM") training courses, and all fees arising from or related to MYM's training services. Initial _____
3. **Cooperation and No Guarantee of Results.** I agree to make a sincere, good faith effort to fully participate in and cooperate with the dog training and instruction provided by MYM, and I acknowledge and agree that each dog is different with regard to ability, breeding, and temperament, and it is not possible for MYM to guarantee that any portion of the training will successfully eliminate or modify my dog's behaviors. 4. **Doggie Gym Use.** I agree to exercise diligent care and assume all risks, dangers and responsibility related to my use of the Doggie Gym, to promptly clean any urination or defecation by my dog while I am present at the at MYM facilities and Doggie Gym, and to follow all rules and procedures related to use of the Doggie Gym, as may be amended from time to time. 5. **Missed Training Classes.** I agree that missed training classes are non-refundable and must be made up within 6 months from the date of the any missed training class, and that I will attempt to notify MYM in advance of any missed class. Initial _____
6. **Health and Vaccinations.** I agree that I will not bring my dog to MYM if I am aware of it exhibiting any signs of illness such as sneezing, vomiting, diarrhea, coughing, lethargy, or any other indication of illness and represent that, to the best of my knowledge, my dog is in good health. I further agree to provide MYM proof that all of my dog's required vaccinations are current prior to my dog's first arrival day and evidence that they remain current for all subsequent arrivals. 7. **Grant of Authority for Emergency Care and Responsibility for Expenses.** In the event MYM determines in its sole discretion that my dog requires medical aid, I authorize MYM, at the sole discretion of MYM staff, to take all necessary actions to obtain the licensed veterinary care of MYM's choice, and to pay and accept full liability for all veterinary and other necessary service expenses incurred by and for my dog during my dog's stay with MYM, including all ancillary services requested. 8. **Warranties and Representations:** I warrant and represent that: (i) if my dog has ever been known to be aggressive towards or to bite or attack another animal or human I have reported all such incidents to MYM; (ii) that all of the information provided by me in this Agreement is true and correct to the best of my knowledge and belief; (iii) that I am the owner of the dog, described above; and (iv) I am authorized to enter into this Agreement. Initial _____
9. **Refusal of Services.** MYM may, at its sole discretion, refuse to provide services to or admit my dog into its training classes. If MYM initially admits my dog into training classes but subsequently determines that in its opinion my dog's behavior is not suitable to participate in the training, then MYM may thereafter refuse my dog's admittance. If MYM initially admits my dog into training but subsequently determines that in its opinion my dog has an illness, then MYM may at its option either segregate my dog in MYM's quarantine room or require that I immediately retrieve my dog. Initial _____
10. **Right to Photograph:** I agree that my dog may be videotaped and/or photographed by MYM. MYM shall be the exclusive owner of the results and proceeds of such taping or photography and may use the same in any of its advertising or marketing. I further agree that my dog may be used in any and all media and the promotion, advertising, sale, or publicizing of MYM. Initial _____
11. **Hold Harmless and Release of Liability.** On behalf of all Owners of my dog, I acknowledge and agree: (i) that MYM shall not be liable for any injuries, illnesses, accidents, or damages to persons (including myself), animals, or property in connection with MYM's services involving my dog including, without limitation, the escape or loss of my dog, the illness of my dog, or any dog bites or attacks during or after my dog visits any MYM facilities, participates in MYM services, or is under the care or custody of MYM (collectively "Activities"), and (ii) to defend, hold harmless and indemnify MYM, and its landlord, owners, employees, and agents from and against any costs, expenses, attorney fees, or damages arising out of any claim, action, suit or proceeding (collectively "Claims") concerning my dog and/or other dogs or animals in the care or custody of MYM or any natural person where such Claim is caused by or relates to my dog during or after my dog engages in the Activities. 12. **Legal Fees:** In the event a dispute arises with respect to this Agreement, the prevailing party shall be awarded all reasonable legal fees and related costs incurred in connection with the dispute. Initial _____
13. **Miscellaneous:** The terms of this Agreement shall not be modified except in writing signed by MYM and the Owner. This Agreement shall be governed by the laws of the State of Washington. The parties agree that venue for any arbitration, suit, or action related to the subject matter of the Agreement shall be exclusive to Clark County, Washington. The words "owner," "my," "I" and other similar words refer collectively to all owners of the above-named dog. I certify that all owners, have read and fully understand the terms of this Agreement and have given me the authority to enter into and execute this Agreement. This Agreement has no time limit and is valid and enforceable for any and all of my dog's future training sessions and stays with MYM. Delivery to MYM of this Agreement signed by Owner may be made by hand, mail, facsimile, or email. Initial _____
14. **Reserved Rights and General Information.** (i) MYM reserves the right to change course schedules, discontinue courses, modify course content, limit class size and cancel courses; (ii) Training fees are payable in advance and subject to change without notice; (iii) (Published course descriptions are for general reference only; (iv) Course documentation and printed material provided in MYM training courses is copyrighted and may not be reproduced without prior written consent; (v) MYM emails a quarterly newsletter, a monthly calendar, occasional promotions emails, as needed weather alerts and notifications for upcoming seminars and workshops/class/daycare cancellation. 15. **Cancelations.** I agree that MYM, at its option, may charge fifty percent of the daycare fee charge for reservations canceled less than 24 hours prior to a scheduled reservation or a "No Show" for a scheduled reservation. Initial _____
